1. **GUIDELINE NO:**

2. **TEST METRIC ID:**
06A208a

3. **TEST TYPE:**
Automated

4. **ATTRIBUTE/INTENT DEFINITION:**
06A2: The network schedule/IMS depicts the sequence of work (horizontal integration) and identifies the significant interdependencies that are indicative of the actual way the work is planned and accomplished.

5. **TEST DEFINITION:**
Do summary tasks/activities in the schedule have logic applied?

6. **TEST METRIC:**
X = Count of summary tasks/activities with logic applied (# predecessors > 0 or # successors > 0)

7. **METRIC THRESHOLD:**
X = 0

8. **DATA ELEMENTS REQUIRED:**
11 Integrated Master Schedule
 11AD Predecessors
 11AJ Successors
 11AL Summary Task UIDs
45 IMS Data Dictionary

9. **ASSUMPTIONS:**
 1. If the scheduling tool does not allow summary tasks/activities, the metric is not applicable.

10. **INSTRUCTIONS:**
 1. Identify and count all summary tasks/activities with relationships (i.e., applied logic); this is the numerator (X) of the test metric.
 2. Use block 7 as an indicator in the overall Risk Assessment to determine if further evaluation is warranted.
 3. For a result above the threshold, determine if the summary tasks/activities with relationships are linked to the same predecessors and successors as their subordinate (i.e., lower level) tasks/activities.
